

Sending Tax Returns by Private Delivery Service

You may use certain private delivery services designated by the IRS to meet the "timely mailing as timely filing/paying" rule for tax returns and payments.

These private delivery services generally include UPS and Federal Express.

After mailing your returns, please contact the private delivery service to obtain an approved mailing receipt.
